Sub.: Revocation of consent to operate Jaipur Plant by Rajasthan State Pollution Control Board.

We wish to inform that the Jaipur Plant of the Company was served yesterday evening with an order by Rajasthan State Pollution Control Board vide their letter no. F(Tech)RPCB/CPM/E-9/852 dated October 27, 2016 revoking the consent given to operate said Plant.

Pursuant to the above, the Company is compelled to close the operations at Jaipur Plant from October 28, 2016.

The Bosch Group always upholds highest standards with respect to environment protection and legality. The Management is confident that the Jaipur Plant has been operating within the prescribed environmental norms and is cooperating with the authorities for an immediate relief. Due to ensuing Diwali holidays and to ensure smooth deliveries to Customers, we are appealing to the Government and Authorities for forthwith withdrawal of the order. Further, the Management is confident that the routine operations will commence soon and negative impact on the Indian Automotive industry can be avoided. We will update further developments as early as possible.

Sub.: Jaipur Plant - update


This is further to our earlier letter dated October 28, 2016 vide which we informed that Rajasthan State Pollution Control Board ("RSPCB") by their letter no. F(Tech)RPCB/CPM/E-9/852 dated October 27, 2016 have revoked the consent to operate the Jaipur Plant.

We now wish to inform that based on the representation made by the Company, RSPCB have kept the above order in abeyance for a period of one month vide their letter no. F(Tech)RPCB/CPM/E-8/862 dated October 28, 2016. Accordingly, the Jaipur Plant will resume routine operations henceforth.
