- 1. Resignation of Dr. Steffen Berns, Managing Director from the close of office hours on 31.12.2016 consequent to assuming a new position in Robert Bosch, Germany.
- 2. Redesignated Mr. Soumitra Bhattacharya, Joint Managing Director as Managing Director of the Company from 01.01.2017 to 30.06.2020, subject to approval of the shareholders of the Company. He is not related to any director of the Company.
