

Information of Tax on Interim Dividend for the Financial Year: 2022-23

Dividend

The Board of Directors Meeting scheduled to be held on 14.02.2023 shall consider the proposal of declaration of interim dividend, if any, for the financial year 2022-23, to the equity shareholders of the Company.

We wish to inform that pursuant to Regulation 42 of SEBI Listing Regulations, Wednesday, February 22, 2023, is fixed as the record date for ascertaining the eligibility of shareholders of the Company, to receive the interim dividend, if declared by the Board of Directors at its meeting.

Pursuant to the changes introduced in the Finance Act 2020, w.e.f. April 1, 2020, the Company would be required to withhold taxes at the prescribed rates on the dividend paid to its shareholders. The withholding tax rate would vary depending on the residential status of the shareholder and the documents submitted by them and accepted by the Company. Accordingly, the above-referred Dividend will be paid after deducting the tax at source as follows:

Notes:

- (1) ***Notwithstanding the above, tax would not be deducted on payment of dividend to resident Individual shareholder, if total dividend to be paid in FY 2022-23 does not exceed Rs. 5,000. In this regard,** please note that the Company has paid dividend of ₹ 210/- per equity share having nominal value of ₹ 10/- for the financial year ended March 31, 2022, during the current financial year, i.e. financial year 2022-23. Accordingly, considering the interim dividend as mentioned hereinabove in the financial year 2022-23, if the aggregate dividend pay-out exceeds ₹ 5,000/-, then the tax will be deducted on the current as well as on the earlier amount of dividend and accordingly, the balance amount of the dividend will be paid to the concerned resident individual shareholder.
- (2) In terms of Rule 37BA of Income Tax Rules 1962 if dividend income on which tax has been deducted at source is assessable in the hands of a person other than the deductee, then deductee should file declaration with the Company on or **before 22.02.2023** in manner prescribed by Rules.
- (3) ****Further,** as per Section 90 of the Act the Non-resident shareholder has the option to be governed by the provisions of the Double Tax Avoidance Agreement (tax treaty) between India and the country of tax residence of the shareholder read with provisions laid down in Multilateral Instrument, wherever applicable. For this purpose, i.e. to avail Tax Treaty benefits, the non-resident shareholder will have to provide documents as specified above.

Kindly note that the Company is not obligated to apply the beneficial Tax Treaty rates at the time of tax deduction/withholding on dividend amounts. Application of beneficial Tax Treaty Rate shall depend upon the completeness of the documents submitted by the Non-Resident shareholder and review to the satisfaction of the Company.

- (4) **Form 10F** :In pursuance of Notification no. 03/2022 dated 16th July 2022, non-resident shareholders are required to furnish Form 10F electronically on income tax portal with their login credentials at portal.incometax.gov.in.

Non-resident shareholders who are not having Permanent Account Number ('PAN') in India or who are not required to obtain PAN in India is exempted till 31.03.23 from mandatory electronic filing of Form 10F, however they are required to submit the manual Form 10F duly signed along with a declaration of not having PAN or not required to obtain PAN in India in the attached format.

(5) TDS to be deducted at higher rate in case of non-filers of Return of Income

The provisions of Section 206AB require the deductor to deduct tax at higher of the following rates from amount paid/ credited to specified person:

- i. At twice the rate specified in the relevant provision of the Act; or
- ii. At twice the rates or rates in force; or
- iii. At the rate of 5%

Where sections 206AA and 206AB are applicable i.e. the specified person has not submitted the PAN as well as not filed the return; the tax shall be deducted at higher of two rates prescribed in these two sections.

As per Central Board of Direct Taxes vide Circular No. 11 of 2021 dated June 21, 2021, for determining TDS rate on Dividend, the Company will be using functionality of the Income-tax department to determine the applicability of Section 206AB of the Act.

The non-resident who does not have the permanent establishment is excluded from the scope of a specified person.

- (6) Shareholders who are exempted from TDS provisions through any circular or notification may provide documentary evidence in relation to the same, to enable the Company in applying the appropriate TDS on Dividend payment to such shareholder.
- (7) Lower deduction Certificate u/s 197 of the Act may be obtained under TAN of the Company i.e., BLRM01746D.
- (8) Shareholders holding shares under multiple accounts under different status/ category and single PAN, may note that, higher of the tax as applicable to the status in which shares held under a PAN will be considered on their entire holding in different accounts.
- (9) The Company with M/s. Integrated Registry Management Services Pvt Ltd, Company's Registrar and Transfer Agent has enabled a shareholder web portal for submission of tax exemption forms/requested documents. Shareholders can submit their tax exemption forms and supporting documents directly on portal for purposes of tax deduction at source by Clicking the below link and selecting '*Bosch Limited*' in the company drop down

We request shareholders to upload the relevant documents at aforementioned link on or before **22.02.2023**.

No communication on the tax determination/deduction received post **22.02.2023** shall be considered for payment of dividend.

- (10) For withholding of taxes as mentioned above, the residential status of the shareholders will be considered as per the data available with the Company/RTA/the Depository Participants (the "DPs"). In case there is change in their status, then the shareholders are requested to update their current status with the Company/RTA/the DPs.

- (11) If the tax on said Dividend is deducted at a higher rate in absence of receipt of or satisfactory completeness of the aforementioned details/documents. The shareholder may claim an appropriate refund in the return of income filed with their respective Tax authorities, if eligible. **No claim shall lie against the Company for such taxes deducted.**
- (12) The Company will arrange to email a soft copy of the TDS certificate at the shareholders registered email ID, post payment of the said dividend. Shareholders will also be able to see the credit of TDS in Form 26AS, which can be downloaded from their e-filing account at <https://www.incometax.gov.in/iec/foportal>.
